

**BOROUGH OF RICHLAND, LEBANON COUNTY, PENNSYLVANIA**

**ORDINANCE 232**

**AN AMENDMENT TO ORDINANCE 232, THE BOROUGH OF RICHLAND PEDDLING ORDINANCE, DELETING PROVISIONS REGARDING LICENSING REQUIREMENTS, APPLICATIONS, AND FEES; DELETING PROVISIONS REGARDING PENALTIES; AND PROHIBITING PEDDLING, CANVASSING, AND SOLICITING EXCEPT FOR THOSE MERCHANTS ENUMERATED IN SECTION 2901(b)(3)(i) OF THE BOROUGH CODE.**

**WHEREAS**, after deliberation and consideration of all information, comments, and concerns from the public, the Council of the Borough of Richland has at determined that the following amendments are beneficial to the health, safety, and welfare of the residents of Richland Borough.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED** by the Borough Council of the Borough of Richland, and it is hereby enacted and ordained, that Ordinance 232 shall be amended as follows:

**SECTION 1.**        **SECTION 2.01 – DEFINITIONS.** shall be amended to delete the following language:

**LICENSE REQUIRED.** No person shall engage in peddling in the Borough of Richland without first having secured a license as herein provided.

**SECTION 2.**        The following Section and language shall be added:

**SECTION 2.02 - PROHIBITION AGAINST PEDDLING.**

With the exception of the activities described in Section 2.01 A. of this Ordinance, no one shall be permitted to engage in peddling, canvassing, soliciting, or taking of orders, either by sample or otherwise, for any goods, wears or merchandise, upon any of the streets or sidewalks, or from house to house in the Borough of Richland.

**SECTION 3.**        The following Sections shall be deleted in their entirety:

Section 2.03 License Application: Nontransferable.

Section 2.04 License Fees.

Section 2.05 License Issuance, Exhibit: Compliance with License.

Section 2.06 Prohibited Times.

Section 2.07 License Suspension.

**SECTION 4.**           **SECTION 2.08 – PENALTY.** shall be amended to provide for a fine of One Hundred (\$100.00) and costs of prosecution for each and every such offense.

**SECTION 5.**           All Ordinances or parts of Ordinances in conflict with these amendments, or inconsistent with the provisions of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 6.**           Should any section or provision of this Ordinance be declared by a Court of competent jurisdiction to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any part thereof, other than the part so declared to be unconstitutional or invalid.

**SECTION 7.**           This Ordinance shall become effective on the date of passage.
