- 6. The president asked for a motion to accept the **2018 Act 511 Taxes of \$5.00 per capita**. Kelly Bricker made the motion to accept the Act 511 Taxes of \$5.00 per capita; Matt Johnson seconded the motion; motion was carried with all members present voting yes.

- 10. The president asked for a motion to approve the **2018 Planning Workshops** to be held the **third Tuesday of each month at 6 pm**, as needed; as advertised in the Lebanon Daily News. Larry Hartman made the motion to approve the 2018 Planning Workshop Meetings, as advertised; Matt Johnson seconded the motion; motion was carried with all members present voting yes.
- 11. President Seldomridge asked for a motion to pass **Resolution #289** to prohibit gambling in the borough, **per PA Legislative Act 42** authorizing a municipality to **prohibit a Category 4 casino** to be located within its municipality. Kelly Bricker made the motion to pass Resolution #289; Larry Hartman seconded the motion; motion was carried with a show of hands from all members present.
- 12. President Seldomridge acknowledged and thanked John Mueller for his 12 years of service, as a member of Borough Council, since this was his last meeting in office.
- 13. Kelly Bricker brought up the issue of cleaning out the state road storm drains. Discussion followed but no decisions were made.

President Seldomridge asked if there were any comments for the good of the Borough.

Since there were no comments, President Seldomridge asked for a motion to adjourn. Larry Hartman made the motion to adjourn; Kelly Bricker seconded the motion; motion was carried with all members present voting yes.
